- If your application is successful, you will be required to sign up to, and comply with, the event organiser's event rules and/or terms and conditions. Please read these carefully, as they will set out the event organiser's obligations and liabilities to you and vice versa.
- Please note that TLC is not responsible for the organisation or management of the event, and therefore we shall have no liability to you for any injury, damage or loss suffered by you when taking part in or in connection with the event.
- You participate in this event at your own risk. TLC will not be held responsible for any injury or illness resulting from your participation in the event. If you are granted a TLC charity place, you agree that you will undertake suitable training and consult your GP if you have any concerns regarding health or injury.
- In the event of being unable to participate due to injury or any other issue, you must let TLC know as soon as possible so that your place may be cancelled.
- If you withdraw after the event entry deadline (which, unless otherwise communicated to you by TLC, is the point at which you have completed your official registration with the event organisers) you may be held responsible for your fundraising commitment.
- The event date, format and capacity may be subject to change by the event organiser due to government guidance, social distance restrictions or for any other reason.
- In the event your race place is affected by any such changes, the event organiser and/or TLC will contact you about your place.
- If the event is cancelled due to Government guidance, TLC will not be held responsible.
- If you are granted a TLC charity place, please note this place is non-transferable. Any attempt to transfer your place may result in this place being lost.
- For this Challenge we require a registration fee of £100 (non-refundable) which must be paid at the point of registration to secure your place.
- In addition, you must pledge to raise a minimum of £2500 in sponsorship money for TLC, to be received within 1 month of the event. The objective is to raise as much sponsorship as possible.
